## 1 SCOPE

- a) This manual describes **the mandatory particulars required to** the register cargo reporters in terms of the provisions of Section 8(1) and the Rules thereto, for the purpose of receiving and processing of sea, air, rail or road cargo reports.
- b) **This manual does not cover:**
- i) The registration requirements as stipulated in the Registration, Licensing and Designation External Policy - SC-CF-19; and
  - ii) The reporting requirements for all conveyances and cargo reports, see SC-CC-38.

## 2 COMPLETION OF THE APPLICATION FORMS

- a) The table below indicates:
- i) Who must register with SARS to submit cargo reports; and
  - ii) The mandatory information that must be provided by the applicant on the application forms:
    - A) DA 8 – Sea cargo;
    - B) DA 8A – Air cargo;
    - C) DA 8B – Rail cargo; or
    - D) DA 8C – Road Cargo
- b) Failure to provide the required mandatory information may result in the rejection of the application.
