

ABAKWA-SARS BAMEMA UMPHAKATHI UKUBA UPHAWULE NGEDOKHUMENTI YOKUBHALWA KABUSHA KWENTELA YEMPAHLA

Pretoria, 5 kuNdasa 2019 – Kulandela isimemezelo esisanda kwenziwa kuSabiwomali sowezi-2019, uPhiko lweziMali eziNgenayo eNingizimu Afrika (SARS) seluhlanganise **idokumenti yezinkulomo-ngxoxo ngokubhalwa kabusha kwentela yempahla** ukuze luqhubeke nenqubo yokuhlelwa kabusha kohlaka lokusebenza lwezomthetho wentela yempahla.

Idokumenti yenkulomo-ngxoxo igqamisa izinto ezaziwayo ekwenganyelweni kwentela yempahla okumele ukubuyekezwa kwentela yempahla kulinganiswe ngazo. Ukwethulwa kanye nokusebenza okukhona manje kohlelo lwentela ngokomthombo *i-duty-at-source* (DAS) lokwenganyelwa kwentela yempahla kuhlinzeka ingqikithi ekubuyekezweni komthetho wentela yempahla. Kukhona amaphutha athile ahlonziwe okumele achitshiyelwe emthethweni okhona manje mayelana namalayisensi e-DAS, ukucwaningwa kwamabhuku, ukuhlola kanjalo nokwesulwa kwentela yempahla. Kuqhathaniswe amazwe ehlukene ukuze kuhlinzekwe ngezibonelo zamazwe omhlaba ezinguqukweni okungakhethwa kuzo. Okokugcina, ukuphetha okufingqiwe kuveza izincomo ezesekwa ngabakwa-SARS.

Idokumeni yenkulomo-ngxoxo ihlose ukuthola amagalelo nokuphawula okuphusile okuzoba usizo kuzo zonke izimboni ezithintekayo ezikhiqiza, zisebenzise, zingenise impahla ezweni nezithelekisa izimpahla ezitheliswayo, kanjalo nakubabambiqhaza bonke kuntela yempahla. Uma kuphela isikhathi sokuphawula komphakathi nokuphawula lokho sekudluliselwe emigudwini efanele, abakwa-SARS bahlose ukukhulumisana namabhodi amele izimboni kanye neminyango kahulumeni ethintekayo ukuze kuqhutshhekwe nezingxoxo kulokhu okuphakanyisiwe okudinga ukuthi kufakwe eminye imibono futhi kulungiswe.
