

# ABAKWA-SARS NEHHOVISI LE-TAX OMBUD BASAYINDE ISIVUMELWANO ESIYINGQOPHAMLANDO

**PRETORIA, ngoLwesihlanu mhla zingama-26 kuMbasu 2019** - Namuhla uPhiko IweziMali eziNgenayo eNingizimu Afrika kanye nehhovisi le-Tax Ombud (OTO) basayinde isivumelwano esiyinqophamlando bakha ubudlelwano bokusebenzisana obuzoletha usizo oluhamba phambili kubakhokhintela.

Lokhu kuzosungula isithangami esisodwa lapho zombili izikhungo zizokhuluma khona izindaba ezithinta izikhungo zombili ngaphandle kokuphambana emiyalelweni ezinikwe yona ngokwehlukana, ikakhulukazi, ezindabeni zenkampani nezokusebenza.

Okusesivumelwaneni kugcizelela ukusebenza ngokuhlanganyela ukuze kugcinwe ukuzimela nokuzibusa kwesikhungo ngasinye.

Okubalulekile, lokhu kumele kuhambisane nemigomo echazwe eMthethweni wokuSingathwa kweNtela.

Lokhu kuyimpumelelo ebalulekile kuzo zombili izikhungo ukuba zizibophezele ebudlelwaneni obuzobhekana nokuxoxisana, ukweskana zinhlangothi zombili kanye nokusebenzisana uma kukhulunyuwa ngezindaba zokudalulwa kolwazi, ukuqequesha, ukudluliselwa kwesikhashana kwabasebenzi baye kwesinye isikhundla kanjalo nokusebenzisana jikelele nokwelekelelana.

IJaji le-Tax Ombud uBernard Ngoepe ukwamukele ukusayindwa kwe-MoU akuchaze njengesinyathelo esihle. Wengeze ngokuthi uyathemba ukuthi lokhu kuzoqeda ukubambezeleka okungenasidiso ekuphothulweni kwezikhalazo zabakhokhintela. "I-MoU esayindiwe ayichazi ukuthi angeke sisabhekana nezikhalazo zabakhokhintela abanazo ngabakwa-SARS ngendlela efanele. Sizoqhubeka nokuba isikhungo esizimele futhi sizoqhubeka senze umyalelo wethu ngobulungiswa nangokungakhethi. Ngakolunye uhlangothi sizinikele ekugcineni ukulingana phakathi kwamandla nemisebenzi yakwa-SARS kanjalo namalungelo nezibophezelo zabakhokhintela, kusho uJaji Ngoepe. IJaji liqhubeke lathi "ngiyethemba ukuthi lokhu (MoU) kuzoba wusizo kubakhokhintela futhi kuzoqinisa zombili izikhungo ekwenzeni imiyalelo yazo ngokufanele."

Uma kwenzeka ngebhadi kube khona izindaba ezithile lesi sivumelwano esingazifakile, kungangenwa ezingcoxweni zeziyvumelwano zosizo oluseceleni uma kuhona isidinga

Kodwa-ke, uma kungafinyelelwa esivumelwaneni kusho ukuthi izinhlangano lezi kumele zixhumane noNgqongqoshe okunguye ozothatha isinqumo esizoba yizwi lokugcina.

Abakwa-SARS bayakwemukela ukuthi umyalelo wehhovisi le-Tax Ombud ukubuyekeza nokubhekana nezikhalazo ezithinta ukuhluleka ukusebenza noma izindaba ezithinta izinqubo noma ukuphathwa kwezindaba ezithile ezivela ngokuthi abakwa-SARS basebenizse uMthetho weNtela ne-CEA ngokungenabulungiswa.

Kubalulekile ukuqaphela ukuthi ihhovisi le-Tax Ombud lingasibuyekeza isicelo uma lowo ofake isicelo eseyihambe yonke imigudu ebekiwe yokufaka izikhalazo kwa-SARS, ngaphandle uma kuhona izimo ezinqala ezenza kungensiwa lokhu.

Kodwa-ke, i-OTO angeke ikubuyekeze lokhu okulandelayo:

- Imithethonqubo noma inqu bomgomo yentela
- inqu bomgomo yakwa-SARS noma umkhuba ojwayelekile, ngaphandle uma kuhlobene noma kuham bisana nodaba lokusebenza noma lwenqubo noma ukuphatha olu vele ngokus etshenzis wa kokuhlinz ekelwa umthetho ngabakwa-SARS
- udaba oluphikis wayo noma okufakwe kulo isicelo sokudluliselwa kwecala, ngaphandle uma kuwudaba lokuphatha olu hlobene nakho lokho kuphikisa nokudlul iswa kwecala; noma
- isinqumo sodaba olu qhubeka noma olungaphambi kwenkantolo yentela.

Futhi, izinqubo nomyalelo wehhovisi le-Tax Ombud zingabuye zibekwe ngemigomo ebekwe ngu Ngqongqoshe.

Abakwa-SARS bakholelw a ukuthi ukubuyekez wa kwezikhalazo okuzimele kungathuthukisa ukufunda ngentela kanjalo nokuqonda kwabakwa-SARS izinkinga zabakhokh intela. Kuzokwenza sibone inkinga yomkhokh intela ngelinye iso kanjalo nokutolikwa komthetho.

Ngalokho-ke uKhomishana wakwa-SARS kanye nehhovisi le-Tax Ombud bavuma ukusebenzisana ngenkathi i-OTO icela ulwazi ezindaben i ezifanayo, kubandakanya ukwazi ukuthola izisebenzi zakwa-SARS ezizokwazi ukusiza i-OTO mayelana nezinhlelo zolwazi, ezindaben i zabasebenzi, ezezimali kanjalo nokutholwa kosizo kanjalo nokwazi ukusebenzisa izikhungo zokuqeqesha zakwa-SARS.
