SARS releases trade statistics for April 2019

Pretoria, 31 May 2019 – The South African Revenue Service (SARS) today releases trade statistics for April 2019 recording a trade deficit of R3.43 billion. These statistics include trade data with Botswana, Eswatini, Lesotho and Namibia (BELN). The year-to-date (01 January to 30 April 2019) trade deficit of R7.55 billion is an improvement from the R16.82 billion deficit for the comparable period in 2018. Exports increased by 17.3% year-on-year whilst imports for the same period showed an increase of 23.8%.

Including trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The R3.43 billion trade deficit for April 2019 is attributable to exports of R103.75 billion and imports of R107.18 billion. Exports decreased from March 2019 to April 2019 by R1.34 billion (1.3%) and imports increased from March 2019 to April 2019 by R6.79 billion (6.8%).

Exports for the year-to-date (01 January to 30 April) increased by 10.8% from R357.14 billion in 2018 to R395.60 billion in 2019. Imports for the year-to-date of R403.14 billion are 7.8% more than the R373.96 billion imports recorded in January to April 2018, leaving a cumulative trade deficit of R7.55 billion for 2019.

On a year-on-year basis, the R3.43 billion trade deficit for April 2019 is a deterioration from the R1.88 billion surplus recorded in April 2018. Exports of R103.75 billion are 17.3% more than the R88.48 billion exports recorded in April 2018. Imports of R107.18 billion are 23.8% more than the R86.60 billion imports recorded in April 2018.

March 2019's trade surplus was revised downwards by R0.29 billion from the previous month's preliminary surplus of R5.00 billion to a revised surplus of R4.71 billion as a result of ongoing Vouchers of Correction (VOC's).

Trade highlights by world zone

The world zone results from March 2019 (revised) to April 2019 are given below.

Africa:

Exports: R27 626 million – this is a decrease of R 547 million from March 2019.

Imports: R13 290 million – this is an increase of R1 688 million from March 2019.

Trade surplus: R14 336 million – this is a deterioration of R2 235 million in comparison to the R16 571 million surplus recorded in March 2019.

America:

Exports: R9 029 million – this is an increase of R1 302 million from March 2019.

Imports: R11 218 million – this is an increase of R1 573 million from March 2019.

Trade deficit: R2 189 million – this is a deterioration of R 272 million in comparison to the R1 917 million deficit recorded in March 2019.

Asia:

Exports: R32 751 million – this is a decrease of R 695 million from March 2019.

Imports: R47 006 million – this is an increase of R3 584 million from March 2019.

Trade deficit: R14 255 million – this is a deterioration of R4 280 million in comparison to the R9 975 million deficit recorded in March 2019.

Europe:

Exports: R27 930 million – this is a decrease of R 615 million from March 2019.

Imports: R33 256 million – this is a decrease of R 281 million from March 2019.

Trade deficit: R5 326 million – this is a deterioration of R 334 million in comparison to the R4 992 million deficit recorded in March 2019.

Oceania:

Exports: R1 432 million – this is an increase of R 385 million from March 2019.

Imports: R1 766 million – this is a decrease of R 186 million from March 2019.

Trade deficit: R 334 million – this is an improvement of R 571 million in comparison to the R 905 million deficit recorded in March 2019.

Excluding trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The trade data excluding BELN for April 2019 recorded a trade deficit of R11.18 billion.

Summary

The R11.18 billion deficit for April 2019 is as a result of exports of R92.63 billion and imports of R103.82 billion. Exports decreased from March 2019 to April 2019 by R0.69 billion (0.7%) and imports increased from March 2019 to April 2019 by R7.71 billion (8.0%).

The cumulative deficit for 2019 is R37.43 billion compared to R44.75 billion deficit in 2018.

Trade statistics with the BELN for April 2019 recorded a trade surplus of R7.76 billion.

Summary

The R7.76 billion surplus for April 2019 is as a result of exports of R11.12 billion and imports of R3.36 billion.

Exports decreased from March 2019 to April 2019 by R0.66 billion (5.6%) and imports decreased from March 2019 to April 2019 by R0.92 billion (21.5%).

The cumulative surplus for 2019 is R29.88 billion compared to R27.93 billion in 2018.
