SARS releases trade statistics for August 2019

Pretoria, 30 September 2019 – The South African Revenue Service (SARS) today releases trade statistics for August 2019 recording a trade surplus of R6.84 billion. These statistics include trade data with Botswana, Eswatini, Lesotho and Namibia (BELN). The year-to-date (01 January to 31 August 2019) trade deficit R0.85 billion is a deterioration from the R4.67 billion surplus for the comparable period in 2018. Exports increased by 6.9% year-on-year whilst imports for the same period showed an increase of 7.6%.

Including trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The R6.84 billion trade surplus for August 2019 is attributable to exports of R122.02 billion and imports of R115.17 billion. Exports increased from July 2019 to August 2019 by R9.46 billion (8.4%) and imports decreased from July 2019 to August 2019 by R1.11 billion (1.0%).

Exports for the year-to-date (01 January to 31 August) increased by 6.9% from R 793.48 billion in 2018 to R847.93 billion in 2019. Imports for the year-to-date of R848.78 billion are 7.6% more than the R788.81 billion imports recorded in January to August 2018, leaving a cumulative trade deficit of R0.85 billion.

On a year-on-year basis, the R6.84 billion trade surplus for August 2019 is deterioration from the R8.49 billion surplus recorded in August 2018. Exports of R122.02 billion are 4.8% more than the R116.42 billion exports recorded in August 2018. Imports of R115.18 billion are 6.7% more than the R107.93 billion imports recorded in August 2018.

July 2019's trade deficit was revised upwards by R0.84 billion from the previous month's preliminary deficit of R2.88 billion to a revised deficit of R3.72 billion as a result of ongoing Vouchers of Correction (VOC's).

Trade highlights by world zone

The world zone results from July 2019 (revised) to August 2019 are given below.

Africa:

Exports: R33 240 million – this is an increase of R2 826 million from July 2019.

Imports: R9 969 million – this is a decrease of R2 069 million from July 2019.

Trade surplus: R23 271 million – this is an improvement of R4 895 million in comparison to the R18 376 million surplus recorded in July 2019.

America:

Exports: R10 346 million – this is an increase of R1 622 million from July 2019.

Imports: R12 662 million – this is an increase of R 481 million from July 2019.

Trade deficit: R2 316 million – this is an improvement of R1 142 million in comparison to the R3 458 million deficit recorded in July 2019.

Asia:

Exports: R35 814 million – this is an increase of R2 627 million from July 2019.

Imports: R50 862 million – this is a decrease of R2 014 million from July 2019.

Trade deficit: R15 048 million – this is an improvement of R4 641 million in comparison to the R19 689 million deficit recorded in July 2019.

Europe:

Exports: R34 445 million – this is an increase of R2 639 million from July 2019.

Imports: R39 536 million – this is an increase of R 1 453 million from July 2019.

Trade deficit: R5 091 million – this is an improvement of R1 186 million in comparison to the R6 277 million deficit recorded in July 2019.

Oceania:

Exports: R1 087 million – this is an increase of R 13 million from July 2019.

Imports: R 1 845 million – this is an increase of R 1 029 million from July 2019.

Trade deficit: R758 million – this is a deterioration of R1 015 million in comparison to the R257 million surplus recorded in July 2019.

Excluding trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The trade data excluding BELN for August 2019 recorded a trade deficit of R4.14 billion.

Summary

The R4.14 billion deficit for August 2019 is as a result of exports of R107.21 billion and imports of R111.35 billion. Exports increased from July 2019 to August 2019 by R7.52 billion (7.5%) and imports decreased from July 2019 to August 2019 by R1.21 billion (1.1%).

The cumulative deficit for 2019 is R67.86 billion compared to R54.26 billion deficit in 2018.

Trade Statistics with BELN countries

Trade statistics with the BELN for August 2019 recorded a trade surplus of R10.98 billion.

Summary

The R10.98 billion surplus for August 2019 is as a result of exports of R14.81 billion and imports of R3.83 billion.

Exports increased from July 2019 to August 2019 by R1.93 billion (15.0%) and imports increased from July 2019 to August 2019 by R0.097 billion (2.6%).

The cumulative surplus for 2019 is R67.01 billion compared to R58.93 billion in 2018.
