SARS releases trade statistics for January 2020

Pretoria, 28 February 2020 – The South African Revenue Service (SARS) today releases trade statistics for January 2020 recording a trade deficit of R1.87 billion. These statistics include trade data with Botswana, Eswatini, Lesotho and Namibia (BELN). The year-to-date (01 January to 31 January 2020) trade deficit of R1.87 billion is an improvement from the R12.61 billion deficit for the comparable period in 2019. Exports decreased by 14.1% year-on-year whilst imports for the same period showed an increase of 1.8%.

Including trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The R1.87 billion trade deficit for January 2020 is attributable to exports of R101.41 billion and imports of R103.28 billion. Exports decreased from December 2019 to January 2020 by R1.45 billion (1.4%) and imports increased from December 2019 to January 2020 by R14.31 billion (16.1%).

On a year-on-year basis, the R1.87 billion trade deficit for January 2020 is an improvement from the R12.61 billion deficit recorded in January 2019. Exports of R101.41 billion are 14.1% more than the R88.87 billion exports recorded in January 2019. Imports of R103.28 billion are 1.8% more than the R101.47 billion imports recorded in January 2019.

December 2019's trade surplus was revised downwards by R0.95 billion from the previous month's preliminary surplus of R14.85 billion to a revised surplus of R13.89 billion as a result of ongoing Vouchers of Correction (VOC's).

Trade highlights by world zone

The world zone results from December 2019 (revised) to January 2020 are given below.

Africa:

Exports: R23 647 million – this is a decrease of R4 259 million from December 2019

Imports: R14 458 million – this is a decrease of R442 million from December 2019.

Trade surplus: R9 189 million – this is a deterioration of R3 816 million in comparison to the R13 005 million surplus recorded in December 2019.

America:

Exports: R9 589 million – this is a decrease of R129 million from December 2019.

Imports: R9 568 million – this is an increase of R992 million from December 2019.
Trade surplus: R21 million – this is a deterioration of R1 121 million in comparison to the R1 142 million surplus recorded in December 2019.

Asia:

Exports: R35 613 million – this is an increase of R3 581 million from December 2019.
Imports: R45 402 million – this is an increase of R6 789 million from December 2019.
Trade deficit: R9 789 million – this is a deterioration of R3 207 million in comparison to the R6 582 million deficit recorded in December 2019.

Europe:

Exports: R22 981 million – this is a decrease of R1 738 million from December 2019.
Imports: R32 246 million – this is an increase of R7 159 million from December 2019.
Trade deficit: R9 265 million – this is an deterioration of R8 897 million in comparison to the R368 million deficit recorded in December 2019.

Oceania:

Exports: R785 million – this is an increase of R112 million from December 2019.
Imports: R1 294 million – this is a decrease of R109 million from December 2019.
Trade deficit: R509 million – this is an improvement of R220 million in comparison to the R729 million deficit recorded in December 2019.

Excluding trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The trade data excluding BELN for January 2020 recorded a trade deficit of R8.54 billion.

Summary

The R8.54 billion deficit for January 2020 is as a result of exports of R90.86 billion and imports of R99.40 billion. Exports decreased from December 2019 to January 2020 by R0.11 billion (0.1%) and imports increased from December 2019 to January 2020 by R14.24 billion (16.7%).

The cumulative deficit for 2020 is R8.54 billion compared to R19.62 billion deficit in 2019.

Trade statistics with the BELN for January 2020 recorded a trade surplus of R6.67 billion.

Summary

The R6.67 billion surplus for January 2020 is as a result of exports of R10.55 billion and imports of R3.88 billion.

Exports decreased from December 2019 to January 2020 by R1.34 billion (11.3%) and imports increased from December 2019 to January 2020 by R0.07 billion (1.9%).

The cumulative surplus for 2020 is R6.67 billion compared to R7.01 billion in 2019.
