SARS releases the preliminary trade statistics for March 2022

Pretoria, 29 April 2022 – The South African Revenue Service (SARS) today releases trade statistics for March 2022 recording a preliminary trade balance surplus of R45.86 billion. These statistics include trade data with Botswana, Eswatini, Lesotho and Namibia (BELN). The year-to-date (01 January to 31 March 2022) preliminary trade balance surplus of R62.10 billion is a deterioration from the R99.06 billion trade balance surplus for the comparable period in 2021. Exports increased by 9.8% year-on-year whilst imports increased by 21.3% over the same period.

<u>Including trade data with Botswana, Eswatini, Lesotho and Namibia</u> (BELN)

The R45.86 billion preliminary trade balance surplus for March 2022 is attributable to exports of R185.82 billion and imports of R139.96 billion. Exports increased by R43.88 billion (30.9%) between February and March 2022 and imports increased by R9.51 billion (7.3%) over the same period.

Exports for the year-to-date (01 January to 31 March 2022) increased by 11.6% to R459.08 billion from R411.49 billion over the same period during 2021. Imports for the year-to-date of R396.98 billion were 27.1% more than the R312.44 billion imports recorded during the same period in 2021. The cumulative trade balance surplus for 2022 is R62.10 billion.


On a year-on-year basis, the R45.86 billion preliminary trade balance surplus for March 2022 was a deterioration from the R53.86 billion trade balance surplus recorded in March 2021. Exports of R185.82 billion were 9.8% more than the R169.27 billion exports recorded in March 2021. Imports of R139.96 billion were 21.3% more than the R115.42 billion imports recorded in March 2021.

February 2022 preliminary trade balance surplus was revised upwards by R0.89 billion due to the ongoing Vouchers of Correction (VOC). The revision was from the preliminary trade balance surplus of R10.60 billion to the revised trade balance surplus of R11.50 billion.



The trade data excluding BELN for March 2022 recorded a preliminary trade balance surplus of R34.34 billion.


Summary

The R34.34 billion preliminary trade balance surplus for March 2022 was as a result of exports of R169.64 billion and imports of R135.30 billion. Exports increased by R41.21 billion (32.1%) between February and March 2022 and imports increased by R9.25 billion (7.3%) over the same period.


The preliminary cumulative trade balance surplus for 2022 was R34.20 billion compared to R74.98 billion trade balance surplus during 2021.

Trade statistics with the BELN countries for March 2022 recorded a preliminary trade balance surplus of R11.52 billion.


Summary

The R11.52 billion preliminary trade balance surplus for March 2022 was as a result of exports of R16.19 billion and imports of R4.66 billion. Exports increased by R2.67 billion (19.7%) between February and March 2022 and imports increased by R0.26 billion (5.9%) over the same period.


The preliminary cumulative trade balance surplus for 2022 was R27.90 billion compared to R24.08 billion in 2021.
