

IZIKHUMULO

Lawa amagceke/izindawo eziqokwe yiKhomishana ngokweSigaba 6 kanye neSheduli eMithethweni ebeka ukuthi kumele kusungulwe izikhumulo.

Umntu osebenza noma uwengamele lezi zikhumulo kumele ahlangabezane nemigomo nemibandela edingwa uMnyango wokuThelisa aphinde ahlizzeke ngesibambiso ngeformu elifanele ngaphambi kokuthi kukhishwe imvume/ilayisensi, ngeminingwane eyengeziwe bheka inqugomgo yamaBhondi/izibambiso i-Bonds policy.

Umntu osebenza noma owengamele lezi zikhumulo kumele, uma izikhumulo sezinezimvume, aphinde abhalise noMnyango wokuThelisa:

- njengombiki wempahla (umsebenzisi we-RCG) ngenhoso yokubika ukungena nokuphuma kwempahla emagcekeni anemvume [ngokulandela uhlelo Iwe-RCG](#); kanye
- nanjengomsebenzisi we-EDI ukuze ezokwazisa ngale mibiko nge-inthanethi iye eMnyangweni wokuThelisa [esebenzisa uhlelo Iwe-RCG](#), bheka ku-[EDI user](#).

Ipulani lesiza kumele lithunyelwe nefomu lokufaka isicelo futhi kumele liveze ngokusobala lokhu okulandelayo:

- UMnyango wokuThelisa ozokwenza imisebenzi yokuphoqeleta umthetho;
- Ukuholwa kwekhontena noma kwebhanoyi elithwala impahla;
- Ukufakwa kwezinto zokuhlola ngemishini ama-scanner;
- Indawo yabaSebenzi boMnyango wokuThelisa yokumisa izimoto; kanye
- nendawo yesikhashana yokugcina izimpahla eziboshiwe noma ezibanjiwe, amakhontena noma izimpahla ezithuthwe ngebhanoyi ngenkathi kusalindwe kuqedelwe izinyathelo okumele zithathwe mayelana nezimpahla.

Okwamanje zisembili izinhlobo zezikhumulo:

Isikhumulo samaKhontena

Isikhumulo samakhontena sagunyazwa ngokweSigaba 6(1)(hB) ezindaweni eziqokwe kuSheduli yeMithetho (Rule 200.08). Zisetshenzelwa ukugcina, ukubopha, ukuthulula noma ukuholla amakhontena noma okuqukethwe amakhontena. Lokhu kwenzelwe ikakhulu izimpahla ezilethwe kwabangenisa izimpahla ezweni bezinto eziqukethwe amakhontena emva kokuthi lezo zinto sezifakwe ngendlela noma uma kupakishwa amakhontena izimpahla ezithelkiswayo.

Izikhumulo zamakhontena, ezipamise ukuba ngaphandle wendawo yechweba, zigunyazwe ngenhoso yokwengeza umthamo wamakhontena kanjalo nenhoso yokuthulula izimpahla ezilethwe umntu noma ukupakishwa kwezimpahla ezizothelekiswa.

Umsebenzi wasesiKhumulweni kumele ahlangabezane nemigomo nemibandela edingwa uMnyango wokuThelisa kanti lokhu kufaka nukufakwa kwsibambiso ngeformu elifanele ngaphambi kokuthi kukhishwe imvume. Ngolwazi olwengeziwe ungabheka amabhondi/isibambiso ama-bonds/surety.

Umninimvume wale ndawo wenza le misebenzi elandelayo kulawa magceke:

- Ukugcinwa kwamakhontena kuze kube ukuthi konke ebikuphethe sekukhishiwe okuzosetshenziswa ekhaya noma kukhishelwe ukuthelekiswa;
- Ukuholulwa kwamakhontena;
- Ukuboshwa, ukubanjwa kwezimpahla noma kwamakhontena;
- Ukuholwa kwamakhontena noma kokuqukethwe amakhontena;
- Ukuethwa kokuqukethwe amakhontena kulowo ongenisa impahla ezweni emva kokuthi okuphakathi sekufakwe ngendlela; noma
- Ukupakishwa kwamakhontena azothelekiswa.

Isikhumulo/idepho yokuhlukanisa

Isikhumulo sokuhlukanisa sagunyazwa ngokweSigaba 6(1)(hC) ezindaweni eziqokiwe kuSheduli yeMithetho (Rule 200.09). Sithi izimpahla ezithuthwa ngendiza/ngebhanoyi zingasuswa esikhumulweni ngaphambi kokuthi zingene zizogcinwa, zizoboshwa, zizothululwa noma zizohlolwa ukupakishwa kwazo noma kokuqukethwe; noma ukuzosuswa

kwazo ziysiswe kwesinye isikhumulo sokuhlukanisa noma ukuhanjiswa kwabangenisa izimpahla ezweni emva kokuba zingenile; noma ngeminye imisebenzi engacaciswa umthetho.

Izikhumulo zokuhlukanisa ngokweSigaba 64G, zisetshenziselwa:

- Ukususwa kwempahla ethuthwa ngendiza/ngebhanoyi isuka esikhumulweni ngaphambi kokuthi zingene endaweni ezipakishwe kuyo;
- Ukuboshwa kwezimpahla ezihamba ngendiza/ngebhanoyi;
- Ukuthululwa kwezimpahla ezihamba ngebhanoyi/ngendiza;
- Ukuholwa kwezimpahla ezipakishwe zahlanganisa noma okuqukethwe;
- Ukususwa ziysiswe kwesinye isikhumulo sokuhlukanisa; noma
- Ukuhanjiswa kwempahla ethuthwa ngendiza/ngebhanoyi kongenisa impahla ezweni emva kokungena kwazo.
