

## Yini uMthelekisi?

Noma ubani (wakuleli noma wangaphandle) ofisa ukuthelekisa izimpahla zisuka eNingizimu Afrika kumele abhalise njengomthelekisi, kubandakanya ukuthelekisa kokuhanjiswa kwempahla okuqhubekayo i-continuous transmission commodities (CTC).

Namuphi owumthelekisi wangaphandle (isib. umuntu noma umuntu onegunya) ofisa ukuthelekisa izimpahla zisuka eNingizimu Afrika kumele abhalise njengomthelekisi bese eqoka i-ejenti ebhalisiwe eseNingizimu Afrika ngaphambi kokuthi umthelekisi wangaphandle ezobhaliswa ukuba athelekise izimpahla ezisuka eNingizimu Afrika.

- Uma engamelelwe i-ejenti ebhalisiwe eseNingizimu Afrika, isicelo kumele simiswe kuze kube ukuthi inkampani yangaphandle iqoke i-ejenti ebhalisiwe; kanti
- Okuyinkampani egunyaziwe, ikhophi egxiviziwe yamadokhumenti okusungula noma nasiphi isitifiketi esikhishwe ngokwemithetho yezwe lapho onemvume wangaphandle noma umuntu obhalisiwe enokubambisana, ebhalisiwe noma aziwa okuqinisekisa lokho kubanjiswa kumele ithunyelwe ngesikhathi kufakwa isicelo.

Izinkampani zangaphandle ezigunyaza izimpahla eziyiswa emazweni angaphandle zidlula eNingizimu Afrika asikho isidingo sokuthi zibhalise eMnyangweni wokuThelisa.

Asikho isibambiso esifunekayo ngenkathi ubhalisa. Kodwa-ke, uMnyango wokuThelisa unelungelo lokufuna isibambiso ngokwesimo sobungozi somfakisicelo.

I-ejenti ebhalisiwe eqokwe inhloko yangaphandle kumele ithwale umthwalo wokwenziwa inhloko yangaphandle okumayelana nokwenzeka ebhizinisini noMnyango wokuThelisa.

Abathelekisi ababhalisiwe kumele babhalise njengomsebenzisi we-EDI uma ezozithumelela yena i-CCD yakhe eMnyangweni wokuThelisa. Uma esebenzisa i-ejenti egunyazayo yoMnyango wokuThelisa enemvume noma i-Ejenti ebhalisiwe, umuntu ongenisa impahla ezweni noma umthelekisi akadingi ukubhalisa njengomsebenzisi we-EDI.

## Ithini inqubo yokubhalisa njengomthelekisi?

- Isitatimende sasebhangeni esigxiviziwe noma esiwungqo esiqinisekisa igama lomnini akhawunti. Inombolo ye-akhawunti kanye nekhodi yegatsha;
- Incwadi evela ebhangeni enophawu lwasebhangeni; noma
- Isitatimende sasebhangeni esiphuma emshinini.
