## Ziyini Izindawo Ezikhethekile Zomnotho (SEZs)

Izindawo Ezikhethekile Zomnotho (SEZs) eNingizimu Afrika ziqokwa ngokomumo wezindawo zezwe ezibekelwe ukwenza izinto ezithinta ezomnotho ukukhuthaza ukukhula kwezomnotho kuzwelonke kanye nokuthlekeisa ngokusebenzisa izindlela zokweseka ezizoheha abatshimali bangaphandle nabakuleli kanjalo nobuchwepheshe.

## Ukushintsha kwama-IDZ akhona okwamanje

Ngokokuhlinzekelwa iSigaba 39 soMthetho i-SEZ Act, 2014, wonke ama-IDZ abesebenza ngaphambi komhla ziyi-9 kuNhlolanja 2016 ngokomthetho azogqukulwa abe ama-SEZ. Namuphi umuntu oyi-IDZ Operator kumele aqinisekise ukuthi i-IDZ iyayithobela imithethonqubo yohlaka lokusebenza ngokomthetho i-SEZ Act, 2014, eminyakeni emithathu (3) yokuqala koMthetho i-SEZ Act, 2014.

## Izindawo ezilawulwa uMnyango wokuThelisa

I-SEZ noma nayiphi ingxenye yayo ingaqokwa ibe indawo elawulwa uMnyango wokuThelisa. Kungase kube khona indawo engaphezulu kweyodwa elawulwa uMnyango wokuThelisa ku-SEZ eyodwa. Lezi zindawo zilawulwa uMnyango wokuThelisa emisebenzini edinga ukubhalisa noma ukuthola imvume ngokwe-Customs and Excise Act, 1964 kanti futhi amagece okwenzelwa kuwo le misebenzi ezolawulwa uMnyango wokuThelisa. Amabhizinisi endawo elawulwa uMnyango wokuThelisa amagece asendaweni elawulwa uMnyango wokuThelisa ngokugcwele lapho imisebenzi edinga ukubhalisa noma ukuthola imvume/ilayisensi eMnyangweni wokuThelisa yenziwa futhi ilawulwa uMnyango wokuThelisa.

## Okuhlinzekelwa isaphulelo

- Izimpahla ezinanoma ziyiphi incazelo ezingeniswe ezweni iBhizinisi lendawo elawulwa uMnyango wokuThelisa elibhalisile endaweni elawulwa uMnyango wokuThelisa zingangeniswa ezweni ngaphansi kwesaphulelo se-rebate item 498.01.
- Izimpahla ezinanoma ziyiphi incazelo ezithelekiswe yi-SEZ Operator ukuze zisetshenziswe ekwakheni nasekugcinweni kwengqalasizinda sendawo elawulwa uMnyango wokuThelisa ku-SEZ zingangeniswa ezweni ngaphansi kwesaphulelo se-rebate item 498.02. Inqalasizinda iphela ezintweni eziyizakhiwo eziyisisekelo ezigxunyekwe ngokugcwele endaweni elawulwa uMnyango wokuThelisa, okufana nokuthuthwa kwendle, ugesi, imigwaqo, amabhuloho kanye nezakhiwo.
- IBhizinisi elisendaweni elawulwa uMnyango wokuThelisa lingafaka izimpahla ngaphansi kwezimpahla ezinesaphulelo ezikuSheduli 3 njengoba kushiwo emthethweni 21A.01 futhi zibhaliswe ngokwempahla leyo, inqobo uma:
